Minors 18 and under must have a minor's release signed at the track in view of the pit registrar. Proof of age and parental custody are required. The release may only be signed by the custodial parent or legal guardian. Drivers under 15 years of age must have prior approval of CRA or CARS Pro Late Model Tour Race Director to compete.
